Fishing

Rules & Regulations

- Turtle Creek users must hold a **valid fishing license** and follow all posted regulations, as well as State and Federal fish and wildlife laws.
- Trotlines, limblines, nets and jugs are prohibited.
- No swimming, camping, water skiing, fires, ice fishing or pleasure boating.
- Shoreline fishing is permitted only in designated areas (see map). Portions of these areas may be closed during waterfowl hunting season and periodic water testing.
- A 20-inch minimum size limit is in effect for largemouth bass, with a daily limit of one.
- Boat ramps and parking are available on a first-come basis.
- Boat launching is permitted only at boat ramps.
- Motor size is limited to 10 horsepower or less; larger motors may be left on the boat, but must be tilted out of the water.

Waterfowl Hunting

Rules & Regulations

- Turtle Creek users must hold a valid hunting license and State and Federal waterfowl stamps. They must follow all posted regulations as well as State and Federal fish and wildlife laws.
- Approximately 33 numbered blind sites are available and are assigned on specified days for hunting (times to be published prior to the beginning of the season). Parties of three and two have priority over parties of one. Locations are available on a first-come basis after the initial selection. Many locations are available only by boat.
- Hunters must provide their own boat with motor size limited to 10 horsepower or less. Launching is permitted only at the main boat ramp area.
- The possession or use of lead shot is prohibited. Maximum steel non-toxic shot size is T.
- State regulations apply unless otherwise specified.
